DUST CONTROL: Dilute product concentrate at a rate of 1:1000 parts water and use solution to spray over area for dust compaction. Use product at a stronger dilution for longer dust control activity.

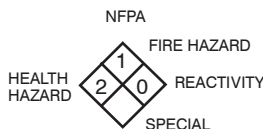
