### **Use Restrictions**

For spot, crack, and crevice application only.

Do not apply more than 112 lbs. (1792 ounces or 89 bottles) of this product (0.56 lbs. ai PBO) per 1000 square feet.

Not for broadcast use on indoor surfaces.

Do not apply this product in a way that will contact adults, children, or pets either directly or through drift.

Do not allow adults, children, or pets to enter the treated area until sprays have dried.

Do not apply when food is present. Remove or cover dishes, ITEM 442000001-20AR

utensils, food processing equipment, and food preparation surfaces, or wash them before use

Remove pets, birds and cover any water inhabited by fish (such as aquariums and ornamental fish ponds) before spray application. Turn off aquarium filtering systems before spraying and wait approximately 15 minutes after application before turning the filter back on.

Do not use in commercial food/feed handling establishments. restaurants or other sites where food/feed is commercially prepared or processed. Not for use in federally inspected meat and poultry plants.

Hold can upright and point spray opening toward nest with wind at your back. Spray until nest is thoroughly saturated to kill the entire nest population. Residual action will kill Wasps and Hornets returning to the nest. Wait at least 24 hours before removing

To kill Wasps, Hornets, Yellow Jackets and Bees under eaves, screens, window frames, doors, patios, cracks, holes ing fish and invertebrates. Do not apply directly to or near or crevices wherever insects are noticed, spray for about 1 water. Drift and run-off may be hazardous to fish and aquatic 2 seconds or until surfaces are moist. To prevent entrance of organisms in water adjacent to treated areas.
