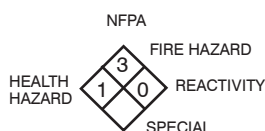
DIRECTIONS FOR USE: DO NOT use more than one fogger per room. DO NOT use in small, enclosed spaces such as closets, cabinets, or under counters or tables. DO NOT use in a room 5 feet by 5 feet or smaller; instead, allow fog to enter from other rooms. Turn off ALL ignition sources such as pilot lights (shut off gas valves), other open flames, or running electrical appliances that cycle off and on (i.e., refrigerators, thermostats, etc.). Call your gas utility or management company if you need assistance with your pilot lights. Do not use this unit in an area less than 100 cubic feet.

Close all windows and turn off air conditioning or heating unit. Place can on raised surface near middle of room. Spread paper or cloth directly below can for protection. To lock valve into open position for total discharge, press valve button all the way down, locking the catch. Then place fogger down and immediately leave the room. Do not disturb area for at least 2 hours. Ventilate room for 30 minutes before re-entering.

DANGER: Extremely Flammable Aerosol. Contains gas under pressure; may explode if heated. Causes serious eye irritation. May cause respiratory irritation, drowsiness or dizziness. Keep away from heat, sparks, open flames, and hot surfaces. –No smoking. Do not spray on an open flame or other ignition source. Pressurized container: Do not pierce or burn, even after use. Protect from sunlight. Do not expose to temperatures exceeding 50°C/122°F. Store in a well-ventilated place. Wash hands thoroughly after handling. Wear eye protection. If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If eye irritation persists: Get medical advice or attention. Avoid breathing mist, vapors and spray. Use only outdoors or in a well-ventilated area. If inhaled: Remove person to fresh air and keep comfortable for breathing. Call a poison center or doctor if you feel unwell. Dispose of contents and container in accordance with local, state and federal regulations.
